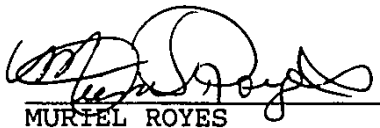

ARTICLES OF INCORPORATION

OF

PAPINE'S PLACE TAKE-OUT RESTAURANT, INC.

The undersigned subscribers to these Articles of Incorporation, are natural persons competent to contract hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be

PAPINE'S PLACE TAKE-OUT RESTAURANT, INC.

The principal place of business of this corporation shall be 91 S. W. 40TH AVENUE, PLANTATION, FL 33317

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful business or activities as permitted under the laws of the United States, the State of Florida or any other State.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having \$1 par value per share.

ARTICLE IV. ADDRESS

The street address of the initial registered office of the corporation shall be 91 S. W. 40TH AVENUE, PLANTATION, FLORIDA 33317, and the name of the registered agent at the address MURIEL ROYES.

ARTICLE V. TERM OF EXISTENCE

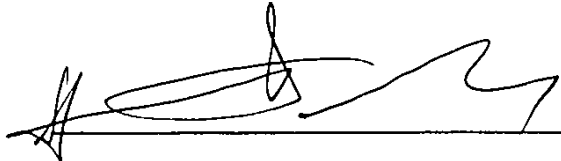
