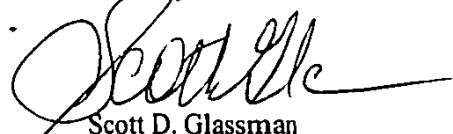

OF
SCOTT D. GLASSMAN, P.A.**

I, the undersigned, hereby execute these articles for the purpose of becoming incorporated under the laws of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of a corporation for profit.

ARTICLE I

The name of this corporation is Scott D. Glassman, P.A.

ARTICLE II

The general nature of the business and the objects and purposes proposed to be transacted and carried on are to do any and all of the things herein mentioned as fully and to the same extent as natural persons might or could do, viz:

- a) To operate a law office; and
- b) Generally, to make and perform contracts of any kind and description and for the purpose of attaining any of the objectives of the corporation; to do and perform any other act or thing; and to exercise any and all powers which a co-partnership or natural person could do and exercise, and which now are or hereafter may be authorized by law; and, generally to do and perform any and all things necessary or incident to the performing and carrying out of the powers hereinabove specifically delegated or implied.

ARTICLE III

The total number of shares of capital stock which may be issued by this corporation is three hundred (100) shares of \$1 par value; all of which shall be common stock and shall be fully paid and non-assessable. No additional shares may be authorized without unanimous approval of the shareholders.

ARTICLE IV

The amount of capital with which this corporation shall commence business is Five Hundred Dollars (\$500.00) capital money paid in.

ARTICLE V

The principal place of business of said corporation shall be at 909 North Dixie Highway, West Palm Beach, Florida 33401, or at such other place as is, from time to time designated by the Board of Directors.

ARTICLE VI

The number of Directors of this corporation shall be up to three (3).

ARTICLE VII

This corporation shall have perpetual existence.

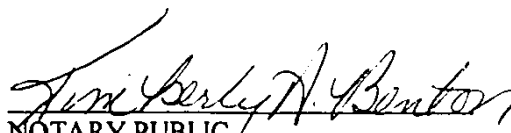
