

ARTICLE I - NAME

The name of this corporation is Cosworth, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 7131 S.W. 8th Court Plantation, Florida 33317

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK
