The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is DIXIE DRY CLEANERS, INC. and the principal office is located at 15300 S.W. 145 Court, Miami, FL 33177 or such other address as the officers may from time to time designate.

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE

PURPOSE

The corporation may engage in any or all lawful business permitted to corporations under the laws of the STATE OF FLORIDA, or any other state, country, territory or nation.

ARTICLE FOUR

CAPITAL STOCK

The maximum number of shares which the corporation has authority to issue is 10,000 shares, all of which shall be common shares with a par value of \$1.00 each.
