The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

ARTICLE I

Name

The name of the Corporation shall be Phu Lock of Kissimmee, Inc.

ARTICLE II

Principal Office

The principal office of the Corporation is located at 7887 Saint Giles Place, Orlando, Florida 32835, and its mailing address is the same.

Corporate Purposes, Power and Rights
