The undersigned incorporator, for the purposes of forming a corporation (hereinafter referred to as the "Corporation") under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I. The name of the corporation shall be Ajacs/<sup>Industries</sup> Inc.

Article II. The principal place of business and mailing address of this corporation shall be 224 Eighth Street, Miami Beach, Florida 33139.

Article III. The number of shares of stock that the corporation is authorized to have outstanding at any one time is 200, all of which are without par value and classified as Common shares.

Article VI. There shall be no preemptive rights.

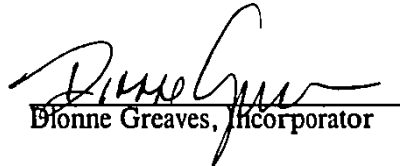
Article VII. The purpose for which the corporation is organized is to engage in any or all lawful business for which corporations may be incorporated under the provisions of the Florida Statutes.

Article VIII. The period of duration of the corporation is perpetual.

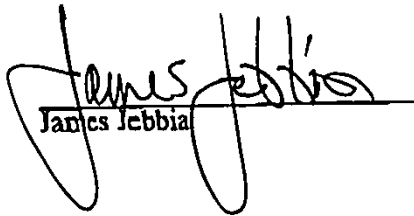

Such indemnification provided shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, Agreement or Resolution adopted by the shareholders entitled to vote thereon after notice.
