### ARTICLES OF INCORPORATION

#### I THROUGH V

Are stated on page one of this document, and have been duly filed with the Department of State, Division of Corporations.

#### ARTICLE VI-CORPORATE PURPOSE

The purpose of Professional Introductions Inc. is stated in its mission statement which is as follows:

Mission Statement:

"At Professional Introductions, we are devoted to bringing together quality individuals for the purpose of introducing those individuals with the goal of creating and fostering long term, mutually beneficial and committed, personal or professional relationships."

#### ARTICLE VII-OFFICERS

A. Titles and Duties-The officers of the corporation shall be the:

President, who is the chief executive officer in responsible for overall operations and day to day decisions of the corporation:

Vice-president, responsible for assisting the president,

Treasurer, responsible for financial operations,

Secretary, responsible for maintaining the minutes, and record keeping.

- B. Election of Officers-The officers shall be elected by a majority vote of the outstanding shares of common stock, on the first Tuesday in June of each year, and shall serve in their respective position for a period of one year.
- C. Removal of Officers- Any officer may be removed for good cause, by a majority vote of the board of directors.

### ARTICLE VIII-BOARD OF DIRECTORS

The Board of Directors shall consist of not less than three nor more than eight individuals, elected by a majority vote of the shares of outstanding stock, on the first Monday in June of each year. Directors, may be stockholders, and may also serve as Officers, however no Director or Officer may hold more than three positions.

#### ARTICLE IX- THE BYLAWS

The bylaws shall set forth the day to day governing terms of the corporation, and shall be

from time to time amended by a majority vote of the shares of outstanding stock. Amendment of the Articles of Incorporation shall require a super majority of **two thirds** of the outstanding shares of stock.
