To whom it may concern:

Last week I received a NOTICE OF INTENT TO DISSOLVE from the Florida Department of State. It occurs to me that this reminder was sent because you did not receive payment for this year.

I did not receive the renewal form, but I neglected to contact the Division of Corporations to request one. This appears to be an oversight on my part since we have been paying our yearly fee since 1997. However, it simply did not occur to me.

I called and left a message to have a form sent to me, and I did receive it yesterday. What I am unclear about is the amount that is due. The postcard reminder states that I must pay the fee within 60 days, but does not indicate that I should send \$550 as a penalty fee.

Enclosed is a check for \$150, the normal fee I have been paying. If, for some reason, this is not acceptable, I will need to reevaluate the current status of PintSize Graphics in terms of tax status.

May I request that someone contact me by mail that the amount I am sending is acceptable and will keep PintSize in good standing? If it is not, please return the check and I will examine other options for my company.
