ARTICLES OF INCORPORATION OF

UPTOWN DETAILING, INC.

The undersigned, for purposes of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE ONE NAME

The name of the corporation is UPTOWN DETAILING, INC

ARTICLE TWO CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE THREE PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

- 1. To engage in the business of motor vehicle, aircraft and watercraft cleaning, detailing and related services.
- 2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
