1. That he is over the age of 18 years and a resident of Hillsborough County, Florida.
2. That he, James R. Kelly, is the President of SUNSTATE EQUITY TRADING, INC., a Florida corporation, (herein "Corporation").
3. That the Corporation failed to file its 2000 Uniform Business Report or pay the 2000 Uniform Business Report filing fee within the time prescribed by Florida Statutes Chapter 607 because:


