Garden Street Deli, Inc., has been a client since its beginnings in 1997. The shareholders, Don and Mary Lou Carr, have been family friends since the early 1960's and clients for most of that time. We have always found them to be conscientious taxpayers and responsible business owners.

However, Mr. Don Carr experienced a rapid decline in health in 2002 leading up to his death, May 12, 2003. Mr. Carr was in the hospital for the last several weeks of his life and therefore unable to tend to the business affairs he usually handled prior to his final illness. In early 2003, Mrs. Carr, who has been largely responsible for management of the day-to-day operations of the business, was further burdened with business matters previously handled by Mr. Carr and, of course, constant trips to the hospital to see her husband of nearly sixty years.
