## ARTICLES OF INCORPORATION

MARIO SAVARD, a natural person competent to contract does hereby subscribe, acknowledge and file in the offices of the secretary of the State of Florida for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida, these Articles of Incorporation as by law provided.

## ARTICLE I

## NAME

The name of this corporation shall be as stated above.

#### ARTICLE II

## GENERAL NATURE OF BUSINESS

This Corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida, including but not limited to SALES.

# ARTICLE III

# CAPITAL STOCK

The maximum capital stock authorized to be issued by this Corporation shall be FIVE HUNDRED (500) SHARES having a par value of ONE (1) DOLLAR per share. Each of said shares of stock shall entitle the holder thereof to ONE (1) vote at any meeting of the stockholders. All or any part of said stock may be paid in cash, in property (other than stock or Securities), or in labor services at a fair valuation to be fixed by the Incorporators, or by the Board of Directors, at a meeting called for such purpose. # CONFLICT OF INTEREST

No contract or other transaction between this Corporation and any other corporation, and no act of this Corporation shall in any way be afflicted or invalidated by the fact that any of the officers of this Corporation are pecuniarily or otherwise interested in are directors or officers of such other corporation provided that any director individually or any firm of which any director may be a member, may be a party to, may be pecuniarily or or otherwise interested in any contract or transaction of this Corporation, provided that the fact he or such firm so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, any Director this Corporation who also is a director or officer of such other corporation who is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this Corporation which shall authorize such contract or transaction with like force and effect as if he were not such director or officer or such other corporation or not so interested.
