**ARTICLE I**

**CORPORATE NAME**

The name of the corporation shall be:

**CarMar Productions Corporation**

**ARTICLE II**

**DURATION**

The period of the duration of the corporation shall be perpetual.

**ARTICLE III**

**PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**ARTICLE IV**

**NATURE OF CORPORATE BUSINESS**

The corporation may engage in or transact any or all activity or business permitted under the laws of the United States and of the State of Florida.

## ARTICLE V

### SHARES

The corporation is authorized to issue and have outstanding at any one time an aggregate number of one thousand (1,000) shares of one class of common stock having a par value of TEN DOLLARS (\$10.00) per share. The consideration to be paid for each share of stock shall be fixed by the Director.

## ARTICLE VI

### DIRECTOR

The number of directors shall be ONE (1). The name of the director who shall act until his successor is duly chosen and qualified is CARLOS FRANCISCO ASSE.

## ARTICLE VII

### PREEMPTIVE RIGHTS

All shareholders of the corporation shall be vested with full preemptive rights.

## ARTICLE VIII

### SPECIAL PROVISIONS

The provisions for the regulation of the internal affairs of the corporation are set forth in the By-Laws of the Corporation.

## ARTICLE IX

### INDEMNITY

The Corporation shall indemnify its director, officers, agent and employees against all expenses and liabilities, including counsel, fees, reasonably incurred by or imposed upon him in connection with any proceeding to which he may be made a party, or in which he may be made a party, or in which he may become involved by reason of his being or having been a director, officer, employee or agent of the Corporation, except in such cases of gross neglect or fraudulent or intentional misconduct in accordance with Florida Statutes 607.014.

### INITIAL REGISTERED AGENT AND STREET ADDRESS

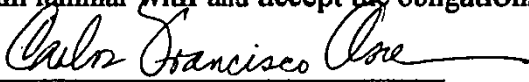

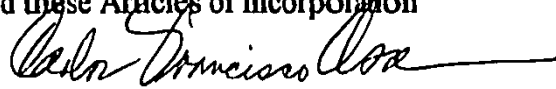
