The undersigned subscriber Donny D. Friesen, a natural person competent to contract, for the purpose of forming a corporation under the laws of the state of Florida, adopts the following Articles of Incorporation for such corporation.

ARTICLE ONE

The name of the proposed corporation is Floors to Go, Inc.

ARTICLE TWO

The corporation is to do business in the retail, wholesale of all types of floor covering including carpet, vinyl, tile, and parquette and to engage in any activity or business permitted under the Laws of the United States and the State of Florida.

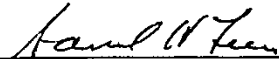
