ARTICLES OF INCORPORATION
OF
TREASURE COAST MEDICAL GROUP, P.A.

ARTICLE I

The name of the corporation is **TREASURE COAST MEDICAL GROUP, P.A.** The principle office and mailing address is:

ARTICLE II

The specific nature of business is the practice of medicine.

ARTICLE III

The corporation shall have perpetual existence.

ARTICLE IV

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 10,000 shares of voting common stock, having a par value of \$.10.

ARTICLE IX


No contract or other transaction between this Corporation and any other corporation, and no act of this Corporation, shall in any

Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of this Corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any director of this Corporation who is also a director or an officer of such other corporation, or who is so interested, may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this Corporation which shall authorize any such contract or transaction with the like force and effect as if he were not such a director or officer of such other corporation, or not interested.

ARTICLE X

This Corporation may indemnify and insure its officers and directors to the fullest extent permitted by law.


