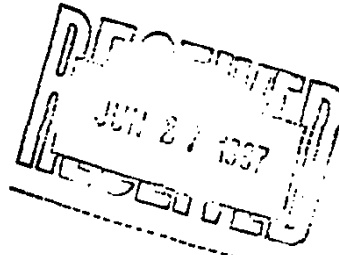

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation is Pamela K. Frazier, P.A. The principal place of business is 125 West Romana Street, Suite 224, Pensacola, Florida 32501.

ARTICLE II

DURATION

The duration of this corporation is perpetual.

ARTICLE III

PURPOSE

The general purposes for which this corporation is organized are:

- (1) To engage in every aspect in the practice of law and related services necessary and incidental thereto.
- (2) To invest its funds in real estate, mortgages, stocks, bonds, and any other types of investments permitted by law.
- (3) To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

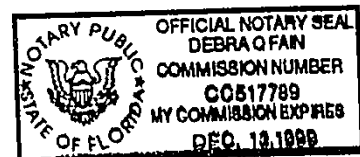
