

1. The name of the corporation is Gremitz Treasures, Inc.
2. The purpose for which this corporation is organized is to transact any and all business for which corporations may be incorporated under Chapter 607, Florida Statutes.
3. The corporation shall have the authority to issue 1000 shares of common stock, in one class only, each with a par value of \$1.00.
4. The registered agent shall be Gregory Siviur and the initial registered office shall be at 145 5th Av. North - Suite 9, St. Petersburg, Florida. The mailing address shall be P.O. Box 1793, Clearwater, Florida, 33757.
