## CERTIFICATE OF INCORPORATION

## MANE GALLERY, INC.

We, the undersigned, each a natural person competent to contract, do hereby associate ourselves together for the purpose of forming a corporation for profit under the laws of the State of Florida, in accordance with the following Certificate of Incorporation.

#### ARTICLE I

The name of this corporation shall be Mane Gallery, Inc..

## ARTICLE II

The general nature of the business to be transacted by this corporation is hair, nails and skin care. To engage in any activities or business permitted under the laws of the United States and of this State, except that it shall not engage in the railroad, canal, telephone, or telegraph business.

#### ARTICLE III

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at one time shall be 1,000 shares of common stock having a nominal or par value of \$1 per share. The amount of capital with which this corporation will begin business shall not be less than Five Hundred (\$500.00) Dollars.

# ARTICLE V

The duration of the corporation shall be perpetual.

# ARTICLE VI

The initial post office address of the principal office of the corporation in the State of Florida shall be 4800 26th Street West, Bradenton, Fl 34207, but this corporation shall have the power of transacting business at such other place or places as the Board of Directors may designate, and it may establish branch offices or places of business in such places within or without the State of Florida as the Board of Directors from time to time may direct.
