**THIS IS TO CERTIFY** that we, the undersigned, all being sui juris, do hereby form a Corporation under and by virtue of the laws of the State of Florida, and do hereby adopt the following articles of incorporation for such corporation:

**ARTICLE I - NAME**

The name of this Corporation shall be 4 J'S METAL FABRICATION, INCORPORATED. The principal place of business of the corporation shall be 2304 N. FLORIDA AVENUE, TAMPA, FL 33602.

**ARTICLE II - NATURE OF BUSINESS**

The purpose of this corporation is to engage in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

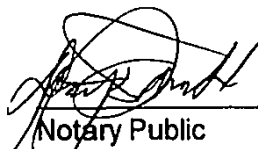

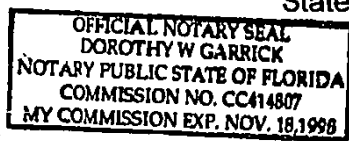
