The undersigned does hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of incorporating Carroll's Bayside Marina, Inc. (the "Corporation"), under the laws of the State of Florida.

ARTICLE ONE - NAME

The name of the corporation is Carroll's Bayside Marina, Inc.

ARTICLE TWO - PRINCIPAL OFFICE AND MAILING ADDRESS

The corporation's principal office shall be located at 97 Pamela Place, Sopchoppy, Florida 32358, and its mailing address shall be 97 Pamela Place, Sopchoppy, Florida 32358.

ARTICLE THREE - TERM OF EXISTENCE
