

ARTICLES OF INCORPORATION

OF

The undersigned incorporator to these Articles of
Incorporation hereby forms a corporation under the laws of
the State of Florida as follows:

ARTICLE I - NAME

The name of the corporation is Diversified Medical Data
Services, Inc.

ARTICLE II - TERM OF EXISTENCE

The date when corporate existence shall commence shall
be on the date these Articles of Incorporation are filed with
the Secretary of State. The corporation shall have perpetual
existence thereafter.

ARTICLE III - PURPOSES

This corporation is organized to include the transaction
of any and all lawful business for which corporations may be
incorporated under the laws of the United States and the
State of Florida as presently enacted and as may be amended
from time to time.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one hundred
shares (100) of one dollar par value stock which shall all be
of one class of Common shares.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the

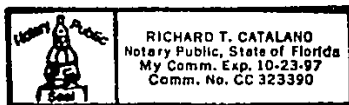
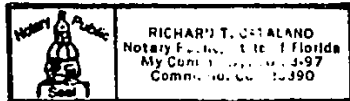
