I, the undersigned, do hereby file these Articles of Incorporation for the purpose of becoming a corporation under and pursuant to the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit, and for that purpose I do hereby certify, declare and set forth as follows, to wit:

#### **ARTICLE I**

#### **NAME**

The name of the Corporation shall be:

OCEANSIDE INSPECTION SERVICES, INC.

#### **ARTICLE II**

#### **GENERAL NATURE OF BUSINESS**

The general purposes for which the corporation is organized are:

- 1. To transact any lawful business for which corporations may be incorporated under the Florida General Corporations Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
  - 2. To do such other things as are incidental to the foregoing or necessary

or desirable in order to accomplish the foregoing:

#### CAPITAL STOCK

This Corporation shall exist perpetually unless sooner dissolved according to law.

#### **ARTICLE VI**

#### PRINCIPAL PLACE OF BUSINESS

#### BY - LAWS
