# ARTICLES OF INCORPORATION

OF

### SAUERKRAUT, INC.



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE I: NAME

The name of the corporation is SAUERKRAUT, INC.

# ARTICLE II: PRINCIPAL PLACE OF BUSINESS
