ARTICLES OF INCORPORATION

OF

GATOR COIN-OP, INC.



ARTICLE I

The name of this Corporation is GATOR COIN-OP, INC.

ARTICLE II Duration

This Corporation shall exist perpetually commencing with the filing of these Articles of Incorporation.

ARTICLE III Purpose

- A. The purpose or purposes for which this Corporation is organized is for the business of engaging in the vending and coin operated machine business.
- B. To engage in any lawful business activity authorized by the statutes of the State of Florida and to have and to exercise all powers now or hereafter conferred by the laws of the State of Florida upon corporations organized pursuant to said laws and all acts mandatory and supplemental thereto.

ARTICLE IV Capital Stock

This Corporation is authorized to issue 7,500 shares of common stock with a par value of \$1.00 each.

ARTICLE V Principal Office

The initial principal office of this corporation is 121 NW Third Street, Ocala, Florida 34475.

ARTICLE VI Initial Registered Agent
