**SECOND:**

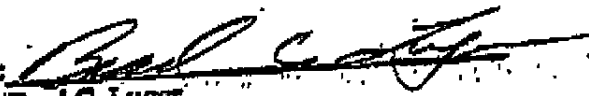
The dissolution of the corporation was authorized on December 21, 1998, by unanimous written consent of the sole director and all the shareholders of the corporation.
