### ARTICLES OF INCORPORATION

#### Princess Park, Inc.

The undersigned Incorporators to these Articles of Incorporation, natural persons competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I. CORPORATE NAME & ADDRESS:

The name of this corporation is:

Princess Park, Inc. 320 Black Oak Court #15-105 Altamonte Springs, FL 32701

#### **ARTICLE II.** NATURE OF BUSINESS AND POWERS:

The general purpose of this corporation shall be the transaction of any and all lawful business. And the Corporation shall have all the powers enumerated in Florida Business Corporation Act as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law.

Also, this Corporation will be able to be engaged in any additional business provided they are lawful business permitted under the laws of the State of Florida.

#### ARTICLE IV. TERM OF EXISTENCE:

This Corporation shall have perpetual existence.

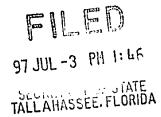
