The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: PATRICIA KAREL MCLAUGHLIN, P.A. The address of the principal office of this corporation shall be: 530 98th Avenue North, Naples, Florida, 34108 and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS
