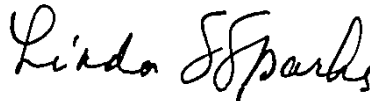

## ARTICLES OF INCORPORATION

OF

### MANOR ENTERPRISE OF N. E. FLORIDA INCORPORATED

The undersigned, for the purpose of forming a general corporation, adopts the following Articles of Incorporation:

#### ARTICLE I

The name of this corporation is Manor Enterprise of N.E. Florida Incorporated with its principle place of business at 8246 Lucaya Court, Jacksonville, Florida 32221.

#### ARTICLE II

##### DURATION

This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if these Articles are not filed by the Department of State of the State of Florida within five days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

#### ARTICLE III

##### PURPOSE AND NATURE OF BUSINESS

The purpose for which this corporation is organized and the general nature of the business to be transacted by this corporation is to engage in every phase and aspect of the business of rendering to the public through this corporation's officers, employees and agents who are legally authorized under the laws of the State of Florida is to render consulting services, particularly those that pertain to and are associated with real estate; provided, however, nothing in these Articles of Incorporation shall be interpreted to prohibit this corporation from investing its funds in real estate, mortgages, stocks, bonds or any other type of investment, or from owning real and personal property necessary for the rendering of such

services. This Corporation will also be involved in other legal purposes of business not so stated in these Articles of Incorporation.

#### ARTICLE IV

##### CAPITAL STOCK

Authorized Capital. The authorized capital stock of this corporation shall consist of 1000 shares of common stock having a par value of \$10.00 per share.

#### ARTICLE V

##### INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 8246 Lucaya Court, Jacksonville, Florida 32221 and the name of the initial registered agent of this corporation at that address is Linda S. Sparks.

#### ARTICLE VI

##### DIRECTORS

(a) Number. This corporation shall have 2 directors initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one.

(b) Initial Directors. The name and street address of the members of the first Board of Directors of this corporation are:

(c) Compensation. The Board of Directors is hereby specifically authorized to make provision for reasonable compensation to its members for their services as directors, and to fix the basis and conditions upon which compensation shall be paid. Any director may also serve this corporation in any other capacity and receive compensation therefor in any form.

(d) Indemnification. The Board of Directors is hereby specifically

authorized to make provisions for indemnification of directors, officers, employees and agents to the full extent permitted by law.

## ARTICLE VII

### RESTRAINT ON ALIENATION OF SHARES

No shareholder of this corporation may sell, hypothecate or otherwise transfer his shares except to another individual who is eligible to be a shareholder of this corporation.

## ARTICLE VIII

### BYLAWS

The initial bylaws of this corporation shall be adopted by the directors. Bylaws shall thereafter be adopted, altered, amended or repealed from time to time by either the shareholders or the directors, but the directors shall not alter, amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to amendment or repeal by the directors.

## ARTICLE IX

### INCORPORATOR

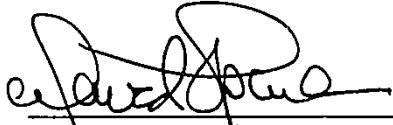

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, and any right conferred upon the shareholders is subject to this reservation.

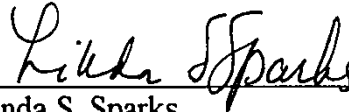
