AFGC PROPERTIES, INC.**

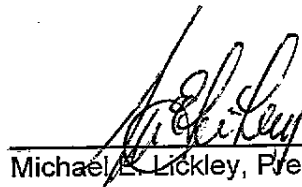

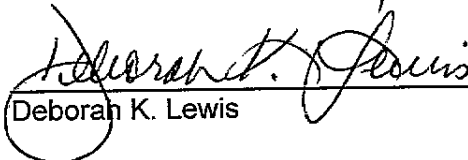
1. The name of the corporation is AFGC PROPERTIES, INC.

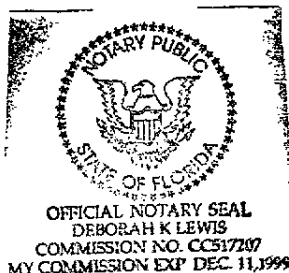

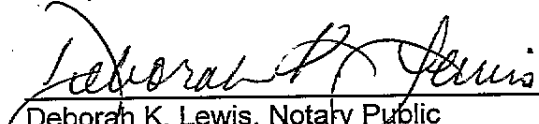
