ARTICLE VIII SHAREHOLDER LIABILITY

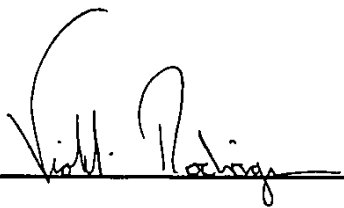
