ARTICLE I. NAME

The name of this corporation is
SEA PRO'S MARINE SERVICES, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

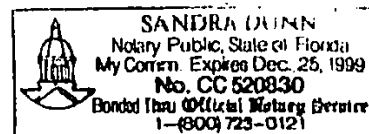
