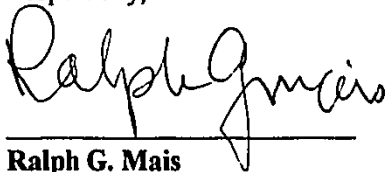

ARTICLE ONE

The name of the corporation is **AMAZE SCREENMAKING PRODUCTS AND SERVICES, INC.** The principal address of the corporation is: 2831 Somerset Drive, Suite B-100, Lauderdale Lakes, Florida 33311.

The period of its duration is perpetual.

ARTICLE FOUR

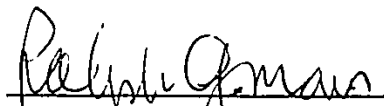
The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100)** of **no par value**.

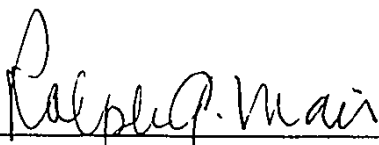
ARTICLE EIGHT
