**ARTICLES OF INCORPORATION**

**OF**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

**ARTICLE I**

The name of the corporation is Peachtree Computer Training & Support Solutions, Inc.

**ARTICLE II**

The duration of the corporation is perpetual.

**ARTICLE III**

The general purpose for which the corporation is organized is to conduct any lawful business for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE IV**

The aggregate number of shares which the corporation is authorized to issue is five hundred. Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00).

**ARTICLE V**


ARTICLE VII

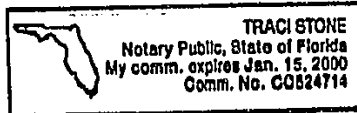


