ARTICLES OF INCORPORATION OF THE JACQUELINE SUSAN BENEFICIAL CORPORATION INCORPORATION INCORPORATION

Article I Name

The name of this Corporation is THE JACQUELINE SUSAN BENEFICIAL CORPORATION, INC.

Article II Principal Office

The principal office of this Corporation is c/o S. CHARLES ADAMS, ESQ., 818 SE 4th Street, Suite 405, Fort Lauderdale, Florida 33301, and the mailing address of this Corporation is c/o S. CHARLES ADAMS, ESQ., Post Office Box 030488, Fort Lauderdale, Florida 33303.

Article III Purpose

The sole purpose of the Corporation will be the operation of an Amway distributorship. No other business may be conducted by the Corporation. It may engage in any legal act relating to that sole purpose.

Article IV Duration

This Corporation shall have perpetual existence.

Article IX Pre-emptive Rights

This Corporation shall indemnify any officer or director or any former officer or director to the fullest extent permitted by law.

Article XI Amendment

This Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation (except Article III hereof) or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

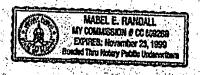
