The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: Mawuya Inc. The English translation for the Shona word Mawuya is: Welcome.

Article 2. Address. The principal office, if known, or the mailing address of the Corporation is: 560 NW 183rd Street, Miami, Florida 33169.

Article 3. Duration. The duration of the Corporation is perpetual
