**CERTIFICATE OF INCORPORATION**  
**OF**

**CANDLELIGHT FLORIST AND WEDDING CHAPEL INC.**

THE UNDERSIGNED SUBSCRIBER TO THESE ARTICLES OF INCORPORATION, A NATURAL PERSON COMPETENT TO CONTRACT, HEREBY FORMS A CORPORATION FOR PROFIT UNDER THE LAWS OF THE STATE OF FLORIDA.

**ARTICLE I**

THE NAME OF THE CORPORATION SHALL BE:

**CANDLELIGHT FLORIST AND WEDDING CHAPEL INC.**

**ARTICLE II**

THE GENERAL NATURE OF THE BUSINESS TO BE TRANSACTED BY THIS CORPORATION IS:

(A) TO ENGAGE IN AND CONDUCT THE BUSINESS OF OPERATION OF A WEDDING CHAPEL AND A RETAIL FLORIST.

(B) TO ACQUIRE BY PURCHASE OR LEASE, OR OTHERWISE, LANDS AND INTEREST IN LANDS AND TO OWN, HOLD, IMPROVE, DEVELOP AND MANAGE ANY REAL ESTATE SO ACQUIRED AND TO ERECT OR CAUSE TO BE ERECTED ON ANY LANDS OWNED, HELD OR OCCUPIED BY THE CORPORATION, BUILDINGS OR OTHER STRUCTURES WITH THEIR APPURTENANCES, AND TO BUILD, ENLARGE, ALTER, IMPROVE ANY BUILDINGS OR OTHER STRUCTURES NOW OR HEREAFTER ERECTED ON ANY LANDS SO OWNED, HELD, OR OCCUPIED, AND TO MORTGAGE, LEASE, SELL, OR OTHERWISE DISPOSE OF ANY LANDS OR INTERESTS IN LANDS AND IN BUILDINGS OR OTHER STRUCTURES AT ANY TIME OWNED OR HELD BY THE CORPORATION.

(D) TO CONDUCT BUSINESS IN, HAVE ONE OR MORE OFFICES IN, BUY, HOLD, MORTGAGE, SELL, CONVEY, LEASE OR OTHERWISE DISPOSE OF REAL AND PERSONAL PROPERTY, INCLUDING FRANCHISES, COPY RIGHTS, TRADE MARKS AND LICENCES IN THE STATE OF FLORIDA AND ALL OTHER STATES AND COUNTRIES. TO CONTRACT DEBTS AND BORROW MONEY, ISSUE AND SELL OR PLEDGE BONDS, DEBENTURES, NOTES AND OTHER EVIDENCES OF INDEBTEDNESS, AND EXECUTE SUCH MORTGAGES, TRANSFER OF CORPORATE PROPERTY, OR OTHER INSTRUMENTS TO SECURE THE PAYMENT OF CORPORATE INDEBTEDNESS AS REQUIRED.
