ARTICLES OF INCORPORATION
OF

ARTICLE VII - AMENDMENT

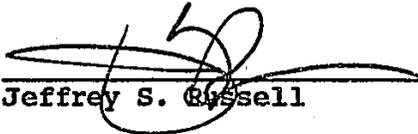

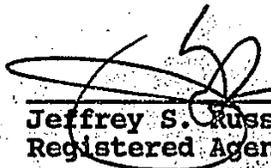
