

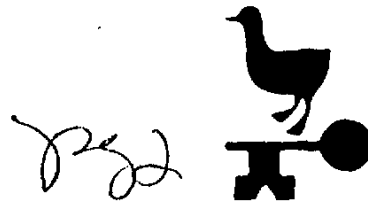
I have enclosed my check for \$450.00 to cover all three Corporations.
