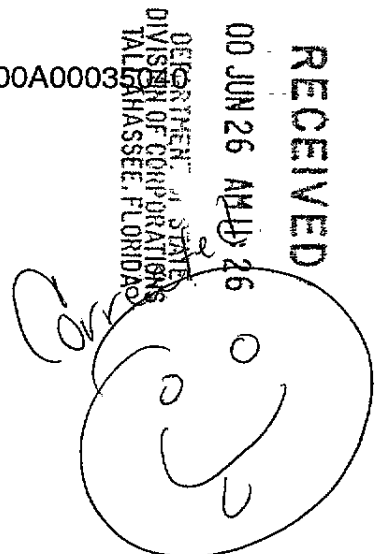


THE UNDERSIGNED, being the sole director and president of August Project II Corp., does hereby amend its Articles of Incorporation as follows:
