ARTICLE I NAME & ADDRESS:

The name of this corporation is ROLANDO ROZAS, M.D., P.A. and the address is 11880 S.W. 46th Street, Suite 202, Miami, Florida 33175.

ARTICLE II DURATION

This corporation is to exist perpetually and it shall commence its existence on the date of filing of the Articles of Incorporation with the Secretary of the State of Florida.

ARTICLE III PURPOSE
