To whom it may concern ,

Much to my surprise , I received the enclosed past due notice for the Annual Corporate Report Filing . I stated that I was surprised to receive such notice , because I have no record of receiving the original filing form .

I do understand the importance of such records , but I am at a disadvantage at this early time in the corporations existence . A-1 Inspections , Inc. was formed as of July 10th 1997 . Due to the uncertainty of completing such an application , I solely depended on my attorney to perform the preparation of all necessary applications. To this date , all corporation records are kept at the attorneys office , Steven Herman P.A. , 38357 5th Ave., Zephyrhills , Fl. 33540 .

Due to this fact , I was under the impression that any reports of such importance would be forwarded to me immediately , or I would be notified by my attorney with an adequate amount of time to complete such documents . I can not explain why I did not receive the original notice , but you can be assured that the month of January (filing deadline) will be highlighted in my calendar from this date forward .

Upon receipt of this notice (July 6th) , I immediately contacted the Division of Corporations office in an attempt to resolve this matter . Therefore , based on that discussion , I am forwarding my explanation of the past events regarding this issue.

I do not expect preferential treatment with this matter , but I am requesting that you accept the original fee which was due . If I had a record of previous filing / filings for this corporation , I would assume full responsibility for it's preparation and I would accept any penalties associated with such documents . Unfortunately , at the current stage of this business , every dollar is important and such a penalty would create a financial hardship on it's part . Income has been very limited and as of the 1997 tax year A-1 Inspections , Inc. was only obligated to pay \$ 200.00 in income tax . My goal is to successfully build this corporation , so hopefully you can understand my concern .

Please review my request and advise my office of your decision .
