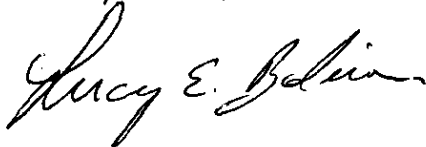
As of today, we have not received a renewal package from the Division of Corporation. I called Tallahassee and I was instructed to send this letter explaining the fact that we still haven't received said package.
