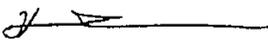

ARTICLES OF INCORPORATION  
OF  
SUNCOAST RESTAURANTS, INC.

ARTICLE ONE

The name of the corporation is SUNCOAST RESTAURANTS, INC. and it's principal office and mailing address is 1857 Venetian Point Drive, Clearwater, Fl. 33765.
