# ARTICLES OF INCORPORATION OF BROWNWOOD, INC.

### Article 1

Name. The name of this Corporation is BROWNWOOD, INC.

#### Article II

<u>Principal Office</u>: The principal place of business and mailing address of this corporation shall be: 2409 S.W. 13<sup>th</sup> Street, Gainesville, Florida, 32601, County of Alachua, State of Florida.

#### **Article III**

<u>Duration</u>. The period of duration of this Corporation shall be perpetual.

#### Article IV

<u>Purpose</u>.
