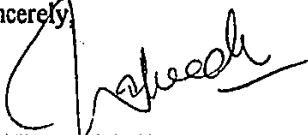

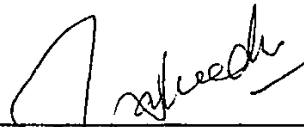
ARTICLE IX - Indemnification :

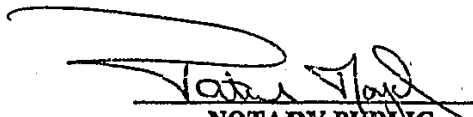

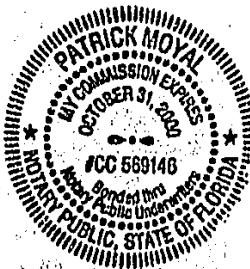
