ARTICLES OF INCORPORATION OF FINE WOODWORKING BY DESIGN, INC.



ARTICLE I: NAME

The name of the corporation is FINE WOODWORKING BY DESIGN, INC.

ARTICLE II: DURATION



The corporation shall have perpetual existence commencing on July 5, 1997.

ARTICLE III: PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV: CAPITAL STOCK

The corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated "Common Shares."

ARTICLE V: PRE-EMPTIVE RIGHTS
