ARTICLE I - NAME

The name of this Corporation is U.N. AUTHORIZED SERVICE CENTER, CORP.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on July 8, 1997.

ARTICLE III - PURPOSE

nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.


ARTICLE X - INCORPORATOR


