The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

ARTICLE I

Name

The name of the Corporation shall be Mankind Clothing, Inc.

ARTICLE II

Principal Office

The principal office of the Corporation is located at 410 North Street, Suite 114, Longwood, Florida 32750, and its mailing address is Post Office Box 915914, Longwood, Florida 32791-5914.

ARTICLE III

Corporate Purposes, Power and Rights


