AMENDMENT TO ARTICLES OF INCORPORATION

WHEREAS, the Articles of Incorporation of ALL*STAR UNIFORM, INC. were filed with and approved by the Secretary of State of the State of Florida on the 14th day of July, 1997; and

WHEREAS, it is the intention of all of the directors and all of the stockholders of ALL*STAR UNIFORM, INC. that the Articles of Incorporation of ALL*STAR UNIFORM, INC. be amended, effective September [6], 1998, in accordance with the proposed amendment hereinafter set forth; and

WHEREAS, the proposed amendment was approved and adopted by all of the directors of ALL*STAR UNIFORM, INC., pursuant to the provisions of Florida Statutes, Section 607.0821, on the 18 day of September, 1998; and

WHEREAS, the proposed amendment was approved and adopted by all of the stockholders comprising the only voting group of stockholders of ALL*STAR UNIFORM, INC., pursuant to the provisions of Florida Statutes, Section 607.0704, on the 18 day of September, 1998; and

WHEREAS, the approval of the Secretary of State of the State of Florida of the proposed amendment hereinafter set forth is hereby requested.

NOW, THEREFORE, the Articles of Incorporation of ALL*STAR UNIFORM, INC. are hereby amended, by adding the following as a new Article X:

"ARTICLE X

The corporation elects to have preemptive rights pursuant to Florida Statutes Section 607.0630."
