1. Name.

2. Principal Office and Registered Agent.

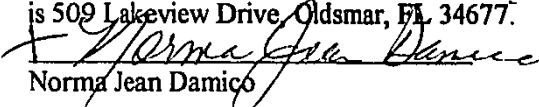
